

Standardised Price List

All funeral directors are legally required to publish this Price List for a standardised set of products and services. This is to help you think through your options and make choices, and to let you compare prices between different funeral directors (because prices can vary).

ATTENDED FUNERAL (funeral director's charges only)

£1,675

This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.

Taking care of all necessary legal and administrative arrangements	£299
Collecting and transporting the deceased person from the place of death (normally within 20 miles of the funeral directors premises) into the funeral director's care	£299
Care of the deceased person before the funeral in appropriate facilities. The deceased person will be kept at both the funeral director's branch premises and at other non-branch premises	£599
Providing a suitable coffin – this will be a fully lined and fitted wood effect coffin	£80
Viewing of the deceased person for family and friends, by appointment with the funeral director (where viewing is requested by the customer)	£49
At a date and time you agree with the funeral director, taking the deceased person direct to the agreed cemetery or crematorium (within 20 miles of the funeral director's premises) in a hearse or other appropriate vehicle	£349

UNATTENDED FUNERAL

This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.

Burial (funeral director's charges only) ¹	Not Offered
Cremation (funeral director's charges plus the cremation fee) ²	£750

FEES YOU MUST PAY

For an Attended or Unattended burial funeral, the **burial fee**.¹ £842-£850

In this local area, the typical cost of the burial fee for local residents is:

For a new grave, you will also need to pay for the plot; for an existing grave with a memorial in place, you may need to pay a removal/replacement fee. In addition, the cemetery may charge a number of other fees.

For an Attended cremation funeral, the **cremation fee**.²

In this local area, the typical cost of a cremation for local residents is: £890

ADDITIONAL FUNERAL DIRECTOR PRODUCTS AND SERVICES

This funeral director may be able to supply a range of optional, additional products and services, or to arrange (on your behalf) for a third party to supply them. Examples include:

Additional mileage (price per mile)	£1.50
Additional transfers of the deceased person's body (e.g. to their home, to a place of worship, etc.) (price per transfer)	£220

The funeral director can give you a full list of what they can supply. They are likely to charge for these additional products and services, so you may choose to take care of some arrangements without their involvement, or you can use a different supplier.

1 This fee (which is sometimes called the interment fee) is the charge made for digging and closing a new grave, or for reopening and closing an existing grave.

2 In England, Wales and Northern Ireland, you will usually need to pay doctors' fees as well. This is the charge for two doctors to sign the Medical Certificates for Cremation.

Terms Of Business

Deposit

If you have selected a Direct Cremation (Unattended Cremation) then the whole amount is due within 48 hours of the initial funeral arrangement.

Otherwise, a minimum deposit is required to be paid within 48 hours of the initial funeral arrangement that will equal the amount of third-party costs to be paid on your behalf (although you can pay more if you prefer). This can vary depending on individual choices but is typically between £900 and £1300 based upon average third party costs in each area.

Payment Options

You can pay by cash, credit/debit card or BACS. Fosters do not charge interest or any other fees with respect of deposit made and final balance.

Full Payment

24 hours after the funeral service date we will send you a final itemised invoice so that you can see clearly what was arranged for you and associated costs.

Any payments you have already made to us in advance of the funeral will be subtracted from the final invoice and the final balance will be shown clearly. Any balance must be paid within 14 days of the invoice date.

Late Payments

We do not add any additional charges for late payment of sums due.
